


LEWISVILLE PUBLIC ART ADVISORY COMMITTEE MEETING MINUTES
January 6, 2025
Town Hall Conference Room 202

- I. **Call to Order** – Chair Barbara Campbell called the meeting to order at 6:00 PM. In attendance were John Armbuster, Barbara Campbell, Holli Conger, Elizabeth Miller, Town Clerk Dora Moore and Town Manager Stacy Tolbert. Rebecca Scherbak was absent.
- II. **Agenda Approval** – Elizabeth Miller moved to approve the agenda to include retreat comments. Holli Conger seconded the motion and motion passed unanimously.
- III. **Minutes Approval** – Holli Conger moved to approve the December 2, 2024 minutes. John Armbruster seconded the motion and motion passed unanimously.
- IV. **Old Business**
 - A. 2025 Art Show – *Loving Life* update – The committee will meet January 27 at 5 PM at MAWCC to review the art submittals.
 - B. MAWCC Mural Call update – Since expanding the artist parameter, Clerk Moore shared four submittals for the MAWCC mural have been received thus far. The committee will review the submittals at the January 23 called meeting.

Consensus was to recommend this piece to Council. The committee had consensus to see if a local resident would be willing to purchase *Bridge in Balance* and donate to the Town since it has been learned that NCDOT will allow art in roundabouts.
